The Better Cotton Initiative (BCI) is looking for a Partnership Officer to provide support to the Partnership team in performing its daily tasks, to continue to scale up Better Cotton and to transform cotton production word-wide. The Partnership Officer will work closely with the Director and Managers of the team. This is a newly created position, for a fixed term until 31 March 2015, but it is envisaged it could be extended further into a permanent position.

The role offers the right candidate an opportunity to work in a multi-stakeholder global organisation focused on developing and promoting more sustainable cotton. To be successful in this role you will need to be culturally versatile, fluent in English and French, and have the ability to communicate clearly and concisely with team members from different parts of the world.

Background

Cotton is one of the most important and widely grown crops in the world. With more than 90% of cotton farmers living in developing countries, millions of poor farmers and workers depend on it for their livelihoods. However, current cotton growing methods need to change as they are placing unsustainable pressures on the environment and the people who produce it. Change means using fewer pesticides, managing water more efficiently, improving soil health and bio-diversity, enhancing fibre quality, and improving the welfare of farm workers.

BCI exists to make global cotton production better for the people who produce it, better for the environment it grows in and better for the sector's future.

BCI works with a diverse range of stakeholders to promote measurable and continuing improvements for the environment, farming communities and the economies of cotton-producing areas.

BCI aims to transform cotton production worldwide by developing Better Cotton as a sustainable mainstream commodity.

BCI's specific aims are to:

- 1. Reduce the environmental impact of cotton production
- 2. Improve livelihoods and economic development in cotton producing areas
- 3. Improve commitment to and flow of Better Cotton throughout the supply chain
- 4. Ensure the credibility and sustainability of the Better Cotton Initiative

Job Announcement – Partnership Officer January 2014 Building on the success to date, where Better Cotton creates positive changes for farming communities, and is being bought by BCI retailer and brand members, BCI has set ambitious targets for the future, increasing Better Cotton volume production 8-fold by 2015 and 26-fold by 2020.

Job Description

Under the supervision of the Partnership Director and working closely with the Partnership Managers, the Partnership Officer is responsible to provide full support to the Partnership Team in securing and ensuring a continued and growing availability of Better Cotton from BCI Partnership Countries.

S/he will handle general inquiries directed to the Partnership Team and undertake initial work associated with new countries applying to become Partners with BCI

S/he will be responsible for preparing regularly or on ad-hoc basis reports for the Partnership Team for both internal and external circulation.

S/he will also liaise with members of other BCI teams to ensure inter-departmental cross-exchange of information.

The role offers the right candidate an opportunity to work in a multi-stakeholder global organisation focused on developing and promoting more sustainable cotton.

To be successful in this role you will need to be culturally versatile, fluent in English and French (at least), have a passion for collaboration and understand what makes for success when organisations enter into deep partnerships.

Responsibilities

Support to the Partnership Team

Under the guidance of the Partnership Managers, the Partnership Officer will provide overall support to the Team in achieving the goal of securing global and diversified supply sources for Better Cotton through partnerships

Specifically the role will be required to:

- 1. Work on individual partnerships to arrange and hold partnership meetings, deliver administrative aspects of the partnership plans, support partnership managers as they review and appraise partnerships, and work with partners to deliver effective processes e.g. information sharing, assessment and referral processes.
- 2. Source information from Partners (as per signed agreements or ad-hoc), and for providing Partners with reciprocal information from BCI.
- 3. Support partnership managers in the monitoring of the existing partnerships and help prepare regular and adhoc reports for both internal and external circulation by ensuring continuous improvement of internal monitoring and evaluating systems for partnerships so that any potential problems are identified and dealt with at an early stage.
- 4. Provide support to the BCI team and to ensure that the local follow up and execution of partnership is in line with the agreements, on track and on time.
- 5. Undertake initial work associated with new countries applying to become Partners with BCI.

Administrative Tasks

- 6. Handle general inquiries directed to the Partnership Team (phone / e-mail).
- 7. Provide support to the team in the overall financial management and reporting of the global partnerships.
- 8. Provide liaison with external consultants &/or contractors (i.e. verification agencies), and handle in coordination with the Standard and Assurance Team the contracting and invoicing phases.
- 9. Liaise with members of other BCI teams to ensure inter-departmental cross-exchange of information.
- 10. To coordinate internal and external meetings.

External Representation & Communication

- 11. Work as focal point and main support resource in the Partnership Team and prepare accurate, timely and complete reports related to activities in partnership countries and to communicate internally and for Better Cotton.
- 12. Contribute materials to communication pieces in order to build BCI and Better Cotton into a well-known and respected brand within and beyond the sustainable cotton sector.



Beyond these specific responsibilities the Partnership Officer is expected to collaborate on activities as agreed with the Partnership Director and the Partnership Managers to support the implementation of the BCI Strategic Plan

Working Arrangements

The successful candidate will report to Partnership Director. The Partnership Officer will receive a fixed term contract, until end of March 2015. The position is full-time and will be based in Geneva, Switzerland. Salary Scale: 50,000-55,000 CHF per annum – dependent on skills and experience.
