During the three years from 2012 to 2014, Guoxin BCI Program has built actively the project training team with leading trainers of planting experts, crop protection experts, and decent work experts; the implementing program involves both large farms and small scale planting units. From 2012 to 2014, Guoxin BCI Program has trained cotton growers with cotton planting acreage of 168,670 mu (11,245 hectares), which produced BCI certified lint of 10,000 tons. Around 20,000 cotton growers have been trained in the program, including 18,600 women growers. In 2015, Guoxin BCI Program plans to plant 40,000 mu (2667 hectares) of cotton in large cotton farms and 500,000 mu (33,334 hectares) in small scale units, and will provide training to 10,006,000 personnel, including 5,005,500 women grower. The target that Guoxin BCI Program team aims at is to benefit more cotton growers through training.
