### BCI's online training platform for you to get access to the Better Cotton Tracer

The Better Cotton Tracer is BCI's traceability system that is used to declare Better Cotton purchases and sales. At least one staff member of your company will have to take a training in order to receive access to the Better Cotton Tracer.

The training series covers the following topics:

- Chain of Custody guidelines: the rules on how to deal with physical Better Cotton along the supply chain
- The Better Cotton Tracer: BCI's traceability system to declare you Better Cotton related purchases and sales

#### PLEASE NOTE:

- The training series consists of several courses, each course has a quiz in the end that you will need to pass in order to proceed to the next course.
- Once you click on the link, a new window opens in your browser prompting you to register.
- After registration you will be taken straight to the first course of the training series.
- You can leave the training at any time and come back using your Mindflash access.
- After you completed the last course of the series, BCI gets automatically notified and your Better Cotton Tracer access will be created.
