## Description

The Better Cotton Initiative (BCI) — the largest cotton sustainability programme in the world — aims to reach 5 million farmers worldwide with more sustainable agricultural practices, and account for 30% of global cotton production by 2020. In less than 10 years, the Better Cotton Initiative and its Partners have supported over 1.6 million farmers in 23 countries in adopting more sustainable agricultural practices. Thanks to these efforts, Better Cotton accounts for around 15% of global cotton production. We are truly a joint effort, encompassing stakeholders all the way from farms to fashion brands and civil society organisations, driving the cotton sector toward sustainability. BCI aims to transform cotton production worldwide by developing Better Cotton as a sustainable mainstream commodity.

BCI is seeking a highly motivated and qualified professional for a fixed-term, one year maternity cover position. At the end of the contract there may be scope for extension into full-time employment.

The BCI Assurance Programme is a field-level system for the regular assessment of farmers around the world participating in the Better Cotton Standard System. Oversight of farmer performance is conducted through various mechanisms, including self-assessment, second party checks, and 3<sup>rd</sup> party verification visits. As an Assurance Manager you will co-lead the execution of the BCI Assurance Programme globally and assume leadership responsibility for a set of designated countries. You will monitor the implementation of annual country-level assurance plans for the remainder of 2018 and both develop and oversee annual country assurance plans for the upcoming year. For your assigned countries, you will oversee all external assessment activities, assume accountability for licensing processes, and ensure the accuracy and timeliness of internal data management. You will play a leading role in helping improve BCI's Assurance Programme at both the procedural and strategic level, ensuring it remains at the forefront of innovation and delivers credible outcomes at scale. The Assurance Manager reports to the Director of Standards and Assurance and works closely with the other members of the Standards and Assurance team and the Global Supply Programme Team across 4 continents.

The Assurance function cuts across internal team structures and you will be the matrix manager for country-specific programme staff, who are responsible for implementing the assurance programme. The position requires travel to certain countries under your remit (approximately 3 one week long haul trips) as well as short-haul travel within Europe (approximately 4 short-haul trips). BCI currently operates either directly or through strategic partnership arrangements in 23 countries globally.

## Responsibilities

### 1. Lead the execution of the BCI Assurance Programme

#### ***Operational management of assurance team***

- Matrix manage country programme staff who are responsible for the execution of country assurance plans, provide leadership and direction, help problem-solve when required and ensure plans are credibly executed in accordance with internal protocols.
- Co-manage the Global Assurance Team (all country programme staff) through the organisation and execution of remote monthly meetings designed to collect feedback from the field work, introduce new processes and templates, provide training and support, and enable cross-country learning and collaboration.
- Oversee the work of the Standards and Assurance Coordinator, which includes supporting the assurance team on procedural developments, coordination of improvements to BCI's online database, and conducting routine and annual assurance outcomes analysis.
- Provide support to Supply Programme Managers in charge of BCI Strategic Partnerships in establishing appropriate and credible assurance protocols for partnership countries

#### ***Oversight of assurance data management***

- Assume accountability for the timely collection, verification and inputting of relevant assurance data, ensuring that BCI's online database holds accurate and up-to-date information.

#### ***Oversight of licensing of farmers under the BCI programme***

- Assume accountability for Better Cotton licences issued at Producer level, including ensuring that all required documentation is signed-off and filed per due process.

#### ***Annual review and planning***

- Assume responsibility for the annual review of the assurance programme delivery through the implementation of internal oversight and reporting mechanisms.
- Ensure that the annual review takes into account feedback from the country programme staff responsible for execution of the Assurance Programme.
- In collaboration with Country Managers, develop annual country level assurance programme plans for the 2019-20 season.

### 2. Contribute to continuous improvement of the BCI Assurance Programme

- Execute planned improvements to existing BCI assurance tools, templates, and procedures, and develop new assurance documentation as required.
- Lead designated projects to integrate and automate assurance mechanisms in BCI's online database and other technology platforms to increase the efficiency of assurance programme implementation.
- Contribute to the current strategic revision of the Better Cotton Assurance Programme, including understanding the complexities present at field-level, supporting the internal

approval process, developing a comprehensive implementation plan and timeline, revising relevant documentation, and preparing and executing training materials.

### 3. Capacity Building

- In collaboration with the other Assurance Manager, plan and deliver periodic training to the Global Assurance Team to ensure they have the skills and competencies required to execute the Assurance Program with integrity, consistency and credibility.
- Support in the design and implementation of training material for BCI Implementing Partners to understand the Assurance Programme and associated IP roles and responsibilities.
- Support the Training and Assurance Manager in the training and monitoring of independent verifiers.

**The candidate will have the following skills, knowledge, and experience:**

#### **Skills and Knowledge :**

##### ***Essential***

- University degree, or equivalent higher education qualification, in a relevant field
- Excellent understanding of what constitutes credible and scalable assurance in the context of global commodity value chains.
- Ability to assess seemingly conflicting requirements and design well-balanced resolutions, meeting strict credibility and scale criteria
- Demonstrated interest in sustainability and international development
- Superior skills and aptitude to appraise arguments critically and logically, organise ideas in a clear and concise manner, and draw conclusions and formulate arguments in way that is effective, concise, precise and specific.
- Excellent analytical and problem solving skills with a proactive approach to finding and proposing solutions to challenges.
- Excellent managerial skills, including clear and concise communication, effective problem-solving, excellent time management, and leadership.
- Fluent in English
- Excellent organisation and capacity to handle multiple priorities.
- Willingness to carry out administrative tasks.
- Excellent IT skills, including: Word; PowerPoint; Excel

##### ***Desirable***

- Academic background in rural/agricultural development and sustainability
- Good understanding of knowledge management, learning and innovation
- Understanding of the training-of-trainers process, monitoring & evaluation or standards systems
- Competency in languages most relevant to BCI countries, such as Mandarin, Portuguese, French, Hindi, Urdu, and Turkish
