Description

The Better Cotton Initiative (BCI) — the largest cotton sustainability programme in the world — aims to reach 5 million farmers worldwide with more sustainable agricultural practices, and account for 30% of global cotton production by the end of the 2020-21 cotton season. In under 12 years, the Better Cotton Initiative and its Partners have supported 2.3 million farmers in 23 countries. in adopting more sustainable agricultural practices. Thanks to these efforts, Better Cotton accounts for around 22% of global cotton production. We are truly a joint effort, encompassing stakeholders from farms to fashion brands and civil society organisations, driving the cotton sector toward sustainability. BCI aims to transform cotton production worldwide by developing Better Cotton as a sustainable mainstream commodity.

BCI's current supply chain integrity programme includes a combination of 2nd and 3rd party audits, conducted on a sampling basis. The chain of custody programme uses a segregation model from the field to the gin, then a mass balance model to the retailers and brand members, with an online system to record purchases and sales through the supply chain. BCI is expanding its chain of custody options – to include a segregated model and physical traceability – and seeking innovative ways to engage all users of the cotton to contribute to sustainable development in the sector by meeting their demand for more sustainable cotton. BCI is recruiting for an experienced sustainability-focused supply chain manager to join our team for a permanent position leading the BCI supply chain integrity programme. The upcoming changes to our chain of custody approach open the possibility for pioneering work for the selected individual.

The successful candidate will have a strong understanding and experience of sustainability standards, compliance and auditing in global supply chains. They will use strategic thinking to innovate and deliver a risk-based approach to assurance and integrity in the supply chain, including anticipating areas of potential risk and, in partnership with our global team, implementing measures to mitigate these risks (e.g. training and communication programmes). This role is an opportunity to shape the future of BCI's supply chain programme, to develop innovative systems to support a more rigorous chain of custody and to enable BCI's continued growth supported by a pragmatic and credible approach to supply chain integrity.

The Role



This role will be responsible for ensuring BCI's supply chain integrity programme is effective and fit for purpose and is set up to accommodate future needs. They will:

- Oversee the implementation of the programme
- Develop the existing programme to improve its effectiveness
- Shape the future design of BCI's supply chain integrity programme

This role will report to the Director of Membership and Supply Chain and will line manage a Senior Supply Chain Coordinator, a Supply Chain Coordinator and provide supervision and support to the Supply Chain team in country offices related to CoC compliance activities. The team may grow and evolve as organisational needs change.

Supply chain integrity strategy development

Building on recent analyses of current approaches and activities, and in conjunction with the Membership and Supply Chain Director and Senior Director Data and Traceability, develop a two-three year strategy for supply chain integrity, including current mass balance system and preparing for future new systems that may be introduced in parallel or as replacement of current systems.

Supply chain programme management

- a) Line manage HQ supply chain staff, matrix-manage supply chain staff based in BCI country offices
- b) Provide supervision and guidance for staff conducting audit sampling and gin monitoring sampling to set compliance monitoring schedules
- c) Responsible for quality of performance of team outputs
- d) Responsible for assessing, tracking and managing risk
- e) Oversee procurement of auditing services
- f) Develop the annual activity plans for supply chain and propose the supply chain budget required to conduct those activities
- g) On-going management and monitoring of the related budget lines, including maintaining an overview of financial expenditure on supply chain compliance activities for each season

Manage CoC developments for BCI's Traceability Programme

- Working closely with the Traceability team to design a segregated or segregated-like Chain of Custody to support the delivery of credible traceability, based on outputs from the CoC research
- b) Provide input to the Traceability team on areas related to CoC Guidelines and CoC assurance
- c) Contribute to activities related to current CoC requirements and assurance in grantrelated activities, and other traceability projects
