Background

A key focus of Better Cotton is Crop Protection and Farmer Health. It is hoped that the incidence and severity of pesticide poisoning in farmers will be reduced by promoting the Better Cotton Principles and Criteria to Farmers. Therefore, a key indicator that Better Cotton wishes to measure is the incidence and severity of poisoning in farmers. Further, Better Cotton wish to know the causes of the poisoning to identify suitable response actions with its Programme Partners.

The measurement of this indicator is difficult due to both the medical aspect of accurately linking incidents of poisoning to specific pesticides, and that many incidents of pesticide poisoning remain hidden because farmers tend to not report these to medical authorities, or the symptoms are incorrectly recorded. Better Cotton wants expert support to measure the incidence of pesticide poisoning in India or Pakistan and then guidance on how Better Cotton and its Programme Partners can measure incidence in future seasons.

Scope of Work

The expected output will be:

- Analysis report with findings on the number, severity and cause of pesticide poisoning cases that occur during the 2024 pesticide spraying months (August – October) for smallholder cotton farmers in up to 8 Programme Partners in India and Pakistan, covering a sample of approximately 400 to 800 smallholder farmers per partner.
- Guidance for Programme Partners on the main pesticides that are causing poisoning and, where possible, the main reasons why pesticide poisoning is happening (for example, lack of protective equipment, improper application, lack of knowledge of risks, hazardous preparation methods
- Guidance for Better Cotton and Programme Partners on how to do our own measurement of pesticide poisoning in the future. This can include training and / or the provision of guidance materials

Please Note Better Cotton Programme Partners in India and Pakistan have Field Facilitators that regularly visit farmers to deliver training, provide ongoing assistance and to collect data. We are open to these Field Facilitators being involved in the collection of data from farmers.

In addition to skills, competencies and expertise, we will consider value for money and demonstrable commitment to the sustainability field to evaluate applications.

Required Skills & Knowledge

Skills, Knowledge and Experience

Essential

8+ of experience of measuring the incidence, severity and cause of pesticide poisoning of smallholder farmers in India and Pakistan

Expert knowledge and understanding of how to collect data on cases of pesticide poisoning, their severity and cause for smallholder farmers in India and Pakistan

Ability to collect data from smallholder farmers in rural areas.

Ability to analyse data and to present findings in English and in a clear and accessible way for staff which are not experts in pesticide poisoning

Ability to collect data using local languages (not English) in both India and Pakistan.

Ability to provide feasible guidance to Better Cotton and Programme Partners on how to collect data in future seasons on pesticide poisoning.

Application Requirements

Proposals responding to this Request for Interest should be a maximum of 10 pages (excluding CVs and the example of previous work), and include the following:

- Overview of relevant experience
- Proposed methodology
- Workplan with key dates / timeline

- Summary of relevant key staff, their role and experience.
- Detailed and transparent budget, in EUROS, including time allocation and day rates. A budget of around 35,000-45,000 Euros is hoped for, with a maximum desired budget of 50,000 Euros available. Value for money a key assessment criterion. A budget above 50,000 Euros will be considered if a clear rationale if provided.
- A relevant example of previous work
- CVs

- Quality and clarity of budget provided, and level of detail included
- Alignment of the budget to the activity timeline detailed in the technical proposal
- Value for money
- Adherence to the available budget
