

Onboarding Checklist

Follow this checklist to onboard to the Chain of Custody (CoC) Standard:



Determine the number of sites your organisation plans to manage Physical Better Cotton from. A site is a single, isolated location where you intend to manage Physical Better Cotton. A site with multiple production steps (vertically integrated) is considered as one site.



Each site needs a separate Better Cotton Platform (BCP) account. Determine if each of your sites already have a BCP account:

- If yes, you can start filling in the CoC Standard Registration Form
- If not, or you are not sure, contact <u>helpdesk@bettercotton.org</u>



Choose the correct CoC Standard Registration Form – there are three options:

- Single Site form
- Online form
 Takes around 15 30 minutes to complete
- Automatically shared with Better Cotton once complete

Multi-site form

- Excel form with a tab for each individual site
- Better Cotton will share a link for uploading documentation
- Submit the Excel form to compliance@bettercotton.org

Lint Trader form

- Excel form with a tab for each individual site (different from the multi-site form)
- Better Cotton will share a link for uploading documentation
- Submit the Excel form to compliance@bettercotton.org

Have the following information and documents ready before completing the CoC Standard Registration Form:

To complete the Registration Form, you will need the following information and documents ready:

- ✓ Your organisations legal, registered name and BCP number(s)
- ✓ Proof of your registered business address
- ✓ Relevant documentation to prove the site(s) are certified to sell GOTS, Fairtrade, OCS/CCS, or other standards (if available), if any.
- ✓ The site(s) most recent internal audit findings, if any.
- ✓ Management system scheme certificate(s) (for example, ISO 90001), if any.
- ✓ Social compliance standard certificate(s), **if any**.


Your business address can be proved by sharing:

- Business License (China)
- Certificate of Incorporation (Bangladesh)
- GST (India)
- SECP (Pakistan)
- Activity Certificate (Türkiye)



Find the CoC Standard Registration Form and guidance:

- The CoC Standard Registration Form and guidance on how to complete it can be found on the main page of the BCP (see the screenshot below).

Submit the form to Better Cotton: your form will be reviewed and assessed within 30 working days. Depending on your assessment result, you might be asked to conduct a third-party verified audit.



Complete e-learning: once approved, you will receive a link to an online e-learning course. After completing the e-learning, your BCP account will be updated within 7 days and you can enter transactions for Physical Better Cotton.



Encourage your suppliers to onboard: you will only be able to buy/sell Physical Better Cotton to organisations that are also onboarded to the CoC Standard. Make sure that your supply chain is onboarded before making any transactions.
