| Can APIs be developed to remove duplication between CB' system and Intact? | Our priority is to ensure the Platform goes live in an efficient and smooth manner. The system has been designed to require minimal information to be inputted by CBs and focus on facilitating communication and tracking of audits. | 04/07/2025 |
| Why can't a CB create or add a producer or SC actor profile in Intact? | The creation and management of a Producer or Supply Chain Actor accounts is carried out by Better Cotton staff within our Salesforce system. Once the Producer or Supply Chain Actor has been created by Better Cotton, the entity will be allocated to a CB in Salesforce and this data will then be pushed through to the Intact Platform where it can then be seen and processed by the CB Admin. | 04/07/2025 |
| Where can Better Cotton staff other than Assurance staff access data from the Intact platform? | For staff members outside of Assurance, relevant data and reports are available via Power BI / Cotton Cloud reporting dashboards. Some information is also available in Salesforce including certification status and date. | 04/07/2025 |
| What specific data fields from Salesforce are used by INTACT and what happens if data is missing or incorrectly entered in Salesforce-does it affect INTACT? | Better Cotton' CRM system is based on Salesforce. Better Cotton manages all certification bodies, producers and supply chain actors accounts in Salesforce. When a Certification Body is allocated to a producer or supply chain actor in Salesforce, a specific set of data is automatically pushed from Salesforce to INTACT — including: • Name of producer / supply chain actor • BCP or BCI number (depending on certification model) • Address / Main email address • Key contact (PU/LF Manager for Producers) • Assigned Certification Body • Certification Bodies' authorised auditors and INTACT users | 27/10/2025 |

| | For producers: Programme Partner, Project code, PU/LF Code, Producer type (PU SH, PU MF, LF, LF Group Certification) For Supply Chain Actors: applicable CoC standard version, whether multisite certification + subsites if multisite. If data is missing or entered incorrectly in Salesforce, either the data is not transferred to INTACT (if breaches API rules) or the same error appears in INTACT because the system mirrors Salesforce information. It is the responsibility of the certification body to inform (and update if changes) Better Cotton of the specific details of the intended scope of certification. Better Cotton Assurance staff must then ensure data accuracy, always verify and update records directly in Salesforce before allocating a certification body. Profiles only appear in INTACT once the Certification Body has been allocated in Salesforce. | |
| Troubleshooting: what do I do if I am experiencing issues with logging in or broken links? | Check that you are using the correct INTACT URL for the live environment (the production link, not the test site). Clear your browser cache or try a different browser. If the issue persists, use the "Forgot Password" option to reset your credentials. | What kind of access will program partners, producers and Supply Chain Actors have to the Platform? | Our priority is to develop a system for facilitating communication between Certification Bodies (CBs) and Better Cotton relating to audit planning and results. There are no immediate plans to allow programme partners, producers or Supply Chain Actors access to the system, especially given many CBs engage with audited entities via their own platforms. Better Cotton may review ways to engage directly with these members and stakeholders via other existing portals re: how we share audit outcomes and information etc. | 04/07/2025 |
| Who can become a CB Admin? | We have requested that each certification body identify at least one (1) member of staff to be their INTACT CB Admin user. This person is in charge of retrieving and entering audit/certification data and documents in INTACT on behalf of the certification body and its auditors. The person designated to be the INTACT CB Admin user might also be an auditor for the certification body, but this is not a prerequisite to becoming a CB Admin. | 21/10/2025 |

| How many CAB Admins can have access to Intact from one CB organisation? | We will allow up to 3 CAB admins for CBs with larger volumes of audits to help manage workloads. In exceptional circumstances, we will consider more than 3 CAB admins. If you feel you need additional licences, please email the request explaining the reasons to compliance@bettercotton.org. In future phases of the project, will look to implement improvements including considering whether there is a need to increase the number of CAB admins as well as further integrations with CBs own systems. | 04/07/2025 |
| Can a CB apply for more user accounts and is there a charge for additional user accounts? | A CB can apply for more user accounts if this is required to aid workload management. There is no charge for additional user accounts but we do have a limited number of licences. Please email the request explaining the reasons to compliance@bettercotton.org. | 14/08/2025 |
| Can Better Cotton setup more roles in Intact such as an Auditor role? | Our priority is to ensure the Platform goes live in an efficient and smooth manner. The system has been designed to require minimal information to be inputted by CBs and focus on facilitating communication and tracking of audits. With this in mind, we decided not to include an Auditor user type in year one and are requesting that the CB Admin user creating an audit order should complete and finalise the audit order in INTACT. We may revisit incorporating an Auditor user type in the future. | 14/08/2025 |
| Why is Better Cotton staff access limited to Assurance staff | Our priority is to ensure the Platform goes live in an efficient and smooth manner. The system has been designed to minimise the no. of user groups accessing the Platform to focus on communication and tracking audits with relevant users efficiently whilst ensuring data protection. For Better Cotton staff members outside of Assurance, relevant data and reports are available via Power BI / Cotton Cloud reporting dashboards. Some information is also available in Salesforce including certification status and date. | 04/07/2025 |

| audit evidence documents? | CBs need to upload the completed Audit Report, the certificate, the Corrective Action Plan, and all supporting documents (includes meeting records, training records, transaction activity documents, registration documents, and any other relevant supporting documentation). In some specific cases, the CB is required to also upload the signed Trademark Licence Agreement. Please refer to the Claims guidance for more information. For P&Cs audits: CBs need to upload (as a minimum) the completed Audit Report, the certificate, and the Corrective Action Plan. Please refer to the P&Cs Monitoring and Certification Requirements for more information. Better Cotton country teams may require additional documents to be uploaded. | |
| How are audits created or completed after 27th June 2025 entered into the INTACT? | Better Cotton manually migrated all audits completed by 27th June 2025. For all other audits, CBs are required to create the audit orders in INTACT and complete all audit data for each Audit (including uploading applicable documents). | 14/08/2025 |
| Is there a deadline for CBs to complete the transfer of audits completed between 28th June and 16th July 2025 (INTACT go live)? | The deadline for CBs to enter all the backdated audit orders is 16 th August 2025. If CBs have a high number of backdated orders to enter and need more time, please contact compliance@bettercotton.org to discuss this. | 14/08/2025 |
| How will CBs update audit dates and maintain accuracy in INTACT? | Certification Bodies are responsible for creating and updating their audit schedules directly in INTACT. To support effective planning, audits should be declared in INTACT at least two weeks before the audit date. | 21/10/2025 |
| As a certification body, how can I check which audits I am due to create in INTACT (i.e. | All producers and companies (suppliers or producers) for which the Certification Body (CB) has not yet created an audit order will appear under the "Order Not Created" tab in the Audit Order Management section of INTACT. This view also allows you to export the list to Excel (by clicking the Excel icon in the top-right corner). This can be useful for generating a report of all auditees that are still awaiting an audit order. | 21/10/2025 |

| How does the memo function work- what should be logged as a memo? How should memos be categorized? | Memos in INTACT serve as a way for Better Cotton Assurance staff to log communications/ observations. Memos can be categorized as Risk, Allegation, or Feedback . When a certification body access the profile of an auditee (Producer o supply chain actor) the existence of a new memo to read is flagged on the first tab of the profile. | 21/10/2025 |
| Is it possible to view all memos rather than accessing each audit order or profile to check whether there is a memo? | Memos are always attached to an audit order or an auditee. There is currently no facility for an "all applicable memos" report/view. | 04/07/2025 |
| Is there an option to mark memos as 'completed' and to verify if the memos have been found and accessed by a CB? | Yes, you can see if Certification Body or Better Cotton staff member updated the memo, but it is not possible to see if the memo has been read. In the future, Intact will be launching a communication/task assignment functionality which will improve communication further. | 04/07/2025 |
| Is there an option to track changes to memos or deleted memos? | Currently it is not possible to view deleted memos. | 04/07/2025 |
| Do memos trigger notifications to CBs or to Better Cotton? | Currently memos do not trigger notifications. A communication/task feature is being developed by Intact and we expect it to be released next year. In the meantime, for cases of urgent communications, we recommend that you send a separate email to the CB representative or Better Cotton Assurance team member to let them know that a memo has been raised in the platform. | 14/08/2025 |

5. Group Certification and Multiple Sites

| Can supply chain actors be certified as multisite in INTACT? | Better Cotton allows supply chain actors to apply for CoC multisite certification (see CoC MAC for more information). Any supply chain actor choosing this approach must be structured in Salesforce (Better Cotton CRM system – see section 1 of this FAQ) so as to reflect a main account/ office (main auditee organisation in INTACT) and respective BCP accounts included in the multisite certificate (site/ sub-sites in INTACT). Certification bodies only create one (1) audit order in INTACT for each CoC multisite certification (i.e. they do not create an audit order for each sub-site). | 21/10/2025 |
| Can producers be certified as a group in INTACT? | The Better Cotton programme in the United States gives producers (large farms) the possibility to apply for Group Certification. This approach allows several large farms to be audited and certified as one (1) group, instead of individual large farms. Any producer benefitting from this approach has been structured in Salesforce (Better Cotton CRM system – see section 1 of this FAQ) so as to reflect a group manager (main auditee organisation in INTACT) and large farms included in the group (site/ sub-sites in INTACT). Certification bodies only create one (1) audit order in INTACT for each group certification (i.e. they do not create an audit order for each large farm). | 21/10/2025 |
| At what level are sites displayed at under the site tab? E.g. for Uzbekistan, would all sites in a cluster be displayed, or just one farm/gin? | As long as the supplier has included those sites in their application to the CB then the site would be displayed on the sites tab. In the Uzbek context the farm/producer will have a separate entry to the rest of the cluster. Then from a CoC perspective, in a cluster this would mean that each site in the cluster should be displayed as long as this information has been provided to the CB. | 04/07/2025 |
| Is the multi-site checklist available in Intact for the | The relevant checklist will appear in INTACT based on the multi- site scenario selected by the CB (A or B) when submitting the initial information to Better Cotton. When completing the checklist | 14/08/2025 |

| Can a Producer or CoC actor be certified by 2 different CBs in INTACT? | Better Cotton controls the allocation of CBs to producers and CoC actors in its CRM system (Salesforce) which updates the INTACT platform. Salesforce and INTACT only allow one CB to be allocated per producer / CoC actor at anyone time. | 14/08/2025 |
| How does the Assurance team's role differ from the CB Admin's role in INTACT? | Assurance staff primarily oversee the accuracy of data, upload documents to help the CB prepare for the audit, log memos, and can sample check audit reports. CB Admins, on the other hand, perform administrative tasks for the Certification Body, including retrieving information shared by Better Cotton, creating audit orders, uploading data and documents for completed audit results, and recording certification decisions. | 21/10/2025 |
| Who is responsible for maintaining producer and supplier profiles (Salesforce vs. INTACT)? | Producer and supplier profiles are maintained in Salesforce, which serves as the primary source. INTACT automatically syncs this information to reflect any updates. INTACT is primarily used for audit information exchange and communication related to audits. If a producer of supply chain actor profile must be updated, the update is carried out in Salesforce. | 21/10/2025 |
| Should Better Cotton Assurance staff still send documents to certification bodies via email, SharePoint, etc? | Any relevant document relating to a specific producer or supply chain actor should be shared via INTACT by uploading relevant documents against a specific producer or supply chain actor profile. This allows Better Cotton and certification bodies to centralise all performance and audit-related information in INTACT, building a record library specific to an auditee. Generic documents such as standard, templates, guidance etc can be accessed by certification bodies online on the Better Cotton website or other agreed resources library. Better Cotton Assurance staff should still use emails for urgent matters or time-sensitive communications, while logging a memo in INTACT provides a record for future reference. | 21/10/2025 |
